REGULATIONS OF THE 24th INTERNATIONAL DRAWING FESTIVAL IN ZABRZE – ONLINE:

I. General provisions:

1. The organizers of the 24th International Drawing Festival are:

- a) School No. 18 in Zabrze
- b) the City of Zabrze
 - Department of Culture and Heritage
 - International Relations Office
 - Municipal Cultural Centre in Zabrze
 - Municipal Centre for Sports and Recreation JSC in Zabrze

2. The objectives of the competition are as follows:

- a) popularisation of fine arts,
- b) development of artistic personality of gifted children and youth,
- c) inspiring the young creators to improve their drawing skills,
- d) promotion of gifted children and youth,
- e) making an artistic reflection on various aspects of cultural reality,
- f) intercultural meetings of artistically talented children and youth from different countries,
- g) promotion of Polish culture and art.

3. Participation in the Festival means acceptance of its conditions, as described in these regulations.

II. Participants

1. The festival is addressed to children, youth and adults from Poland and abroad, hereinafter referred to as Authors.

2. The festival will be divided into age categories:

The age categories of festival participants are as follows:

- 1st category – with no limits – special schools, people with disabilities,
- 2nd category – from 3 to 6 years of age – kindergartens,
- 3rd category – primary schools, classes I-III,
- 4th category – primary schools, classes IV-VI,
- 5th category – primary schools, classes VII-VIII and first classes of secondary schools,
- 6th category – secondary schools,
- 7th category – art schools /LSP, LP, OSSP/,
- 8th category – from 20 to 25 years of age – high schools, universities,
- 9th category – from 26 to 100 years of age.

III. Regulations related to drawings

1. The competition consists in making a drawing study of a person from nature, taking into account the subject: SILESIAN PERSON OF THE FUTURE.
2. The drawing has to be done by any drawing technique, on any groundwork (canvas, cardboard, paper or other) of any format.
3. The drawing should be properly photographed and described when ready.
4. The authors work individually.
5. The drawings of Festival participants may in no part be plagiarism, a copy or part of any other work. They cannot as well be the drawings that were published in media or were presented in other competitions.
6. Each published drawing should be described in the post placed on the Facebook profile “Międzynarodowy Festiwal Rysowania w Zabrzu – official”
